**IDAPP DEMAND STUDENT LOAN
REVENUE NOTES/LIQUIDITY FACILITIES**

Summary: This item is required to appear on every Commission meeting agenda to cover contractual requirements for Demand Note/Liquidity Facility financings. It will not be necessary to take action unless the prime rate exceeds 16.75 percent on the business day immediately prior to the date of the Commission meeting.
